THE CHARTER AGREEMENT BETWEEN THE EBCAF AND EACH COURAGE HOUSE REQUIRES THAT THE COURAGE HOUSE AND ITS RESPECTIVE NFL TEAM WORK TOGETHER TO HAVE AN ANNUAL EVENT HONORING THEIR TEAM'S COURAGE AWARD RECIPIENT. THE EBCAF WORKS WITH EACH COURAGE HOUSE TO ASSIST THEM IN ORGANIZING THIS EVENT, SO THAT IT CAN BECOME A MAJOR FUNDRAISING SOURCE FOR THE COURAGE HOUSE.

THE EBCAF ORGANIZES AN ANNUAL EVENT IN BALTIMORE TO HONOR ALL 32 COURAGE AWARD RECIPIENTS, ONE FROM EACH NFL TEAM. THESE RECIPIENTS ARE SELECTED BY THEIR TEAMMATES WHO FEEL THAT THEY EXEMPLIFY A COMMITMENT TO THE PRINCIPLES OF SPORTSMANSHIP AND COURAGE. THE AWARD HAS BECOME ONE OF THE MOST PRESTIGIOUS HONORS AN NFL PLAYER CAN RECEIVE, ESPECIALLY SINCE THE WINNERS ARE CHOSEN BY THEIR PEERS. THE RECIPIENTS SPEND SEVERAL DAYS IN BALTIMORE FOR THIS EVENT. THEY VISIT THE BALTIMORE RAVENS COURAGE HOUSE TO MEET AND INTERACT WITH THE CHILDREN WHO RESIDE THERE.
